Image Reproduction: Terms and Conditions



Permission to reproduce Images from Oxford University Museum of Natural History (OUMNH) is dependent on full acceptance of the following Terms and Conditions, unless otherwise agreed, and is automatically withdrawn if any part is infringed.

In these Terms and Conditions, 'image' means a digital photograph, computer generated facsimile, scan, 3D scan, or any other item which is held by OUMNH as a digital image and can be offered for the purposes of reproduction.

- 1. The purchase of an image does not in itself carry with it the right to make a reproduction in any form. OUMNH reserves copyright (as defined in the Copyright Act 1956 and the Copyright, Designs and Patents Act 1988) on all reproductions, where applicable. Images of works for which OUMNH does not hold copyright can only be supplied, other than for research or private study, if written consent from the owner of the copyright is supplied by the applicant. The Museum will advise in regard to the ownership of copyright in these cases.
- 2. All reproductions must credit ©Oxford University Museum of Natural History or otherwise acknowledge the Museum in line with relevant publication submission guidelines.
- 3. OUMNH shall not be liable for any loss or damage suffered by the Licensee or by any third party arising from the use of any of the images.
- 4. OUMNH reserves the right to reject any requests for photographic reproductions at its discretion. Reproductions will not be made for material to which reproduction could cause damage to the item.
- 5. A fee may be applicable for the supply of an image. Where an existing reproduction does not already exist it may be possible to arrange new photography. There will be an additional charge for this service. Fees must be paid in full before the image will be supplied.
- 6. Permission to reproduce the supplied image or media is strictly limited to the purpose as detailed on the Image Reproduction Licensing Form. Any additional use of the supplied images, for example all reprints, further editions or re-employment of images in other projects, require a new application.
 - i. A license to reproduce in a book or journal also covers ebook rights where both are versions of the same publication. No separate rights application needs to be made to cover ebook rights.

- ii. By signing and completing the Image Reproduction Licensing Form you give OUMNH permission to publish the bibliographic reference of the publication in question on the public facing collections database.
- 7. All fees are for non-exclusive, one-time use only; rights are not granted in perpetuity. No third party will be permitted to use the material supplied by OUMNH, other than for the purpose stated on the Image Reproduction Licensing Form.
- 8. No images supplied may be stored in a digital archive, electronic or computerised device nor be duplicated for further use. All supplied images will be destroyed and/or deleted once they have been used for the purpose stated on the Image Reproduction Licensing Form.
- 9. No manipulation of the image, other than for colour correction, is allowed without written permission granted in advance by OUMNH.
 - i. No part of the image may be cropped, edited, masked out, cut down, superimposed with typed matter, or in any way defaced without prior agreement.
 - ii. Where only a part of a work is reproduced with specific permission from OUMNH, the word 'detail' will be included in the caption.
- 10. Website, commercial (non-publication/advertising) and TV/Film uses are granted for 10 years.
- 11. Reproduction (in any form) of images of the Museum or its collections not supplied by OUMNH (either as part of this application or a previous application) is strictly prohibited unless written permission is given. For instance, the publication of images taken as part of a visit or research appointment to OUMNH is prohibited without permission.
- 12. Unless otherwise agreed, one copy of any product, publication, publicity material or similar produced by the Licensee and containing a reproduction of the Image must be supplied by the Licensee to OUMNH in hard copy or digital form within six (6) weeks of its publication or production.

No variation of the Terms and Conditions set out herein shall be effective unless agreed in writing by both parties.
